**Kolkata, the 28<sup>th</sup> June, 2024**

**NOTIFICATION**

Whereas, exemption of tax and additional tax in respect of two wheeler and four wheeler electric vehicles (BOV) and all categories of CNG vehicles was allowed in terms of the budget statement of the Hon'ble Minister of State, Finance on 11.03.2022 for two financial years starting from 01.04.2022 and ending on 31.03.2024; and

Whereas, the exemption was notified under Notification No.1787-WT dated 25.05.2022 for the period from 01.04.2022 and ending on 31.03.2024; and

Whereas, the OEMs manufacturing BOV and CNG vehicles have been requesting this department to extend the facilities offered to the green fuel operated vehicles beyond 31st March 2024; and

Whereas, the registration of CNG fuelled and battery operated electric vehicles has increased significantly during the exemption period from 01.04.2022 and ending on 31.03.2024 in comparison to the corresponding period; and

Whereas it is felt necessary to extend the exemption period for another financial year;

Now, after careful consideration, the Governor is pleased to extend the period of exemption till 31.03.2025 and also orders that other terms and conditions of Notification No.1787-WT dated 25.05.2022 shall remain unchanged.

This has been issued with concurrence of Finance Department vide their UO No. Group R/2023-2024/0371 dated 13-03-2024 and approval of the Cabinet vide Cabinet Secretariat UO No.CAB(D)-1004 dated 27.06.2024.

This comes into effect from 01.04.2024.
